# District 7 Opportunities!!

- 1. **Alternate DCM**—this position fills in for the DCM should he/she be unable to perform his/her duties as needed. Duties include attending all monthly district meetings as well as Area meetings each quarter and assemblies in the Spring and Fall.
- 2. Public Information (PI)—this position is responsible for making AA accessible when anyone reaches out for help. Duties include attending all monthly district meetings, ensure meeting schedules are available and up to date, follow AA guidelines for PI. Also attend Area meetings each quarter and assemblies in the Spring and Fall.
- 3. Cooperation with the Professional Community (CPC)—this position provides the professional community (which comes into contact with alcoholics) with information about what AA is, what AA does and does not do, and how to contact local AA. Duties include attending all monthly district meetings as well as Area meetings each quarter and assemblies in the Spring and Fall.
- **4. Archives**—the archivist collects, organizes, and stores historical materials which are pertinent to the district. Duties include attending all monthly district meetings, reporting acquisitions, and providing access to materials when appropriate/requested.

Would you like to get involved in AA service work? Please consider coming to district and expressing your interest in an open position. Your involvement can help ensure the services we provide in our district for the still-suffering alcoholic are the best we can. Generally, 2-years of continuous sobriety (current) are recommended. All positions are filled by election from the district body.
